Web and Mobile based application.




Officials can define different Road Maintenance KPIs with Bench mark and Penalty amount.

 - Contractor can address the work by uploading After photo with Geo-Tagged.


WEB APPLICATION SCOPE -


- To design the Dynamic dashboard for the Contractor and NMMC Officials $\langle \rightarrow \rangle$
